The protection of your personal data is a constant concern for WinTimePro

Please find below the set of rules and guidelines that we impose on ourselves to protect them. Please read them carefully.

What you need to know first;

This document is also applicable to B2C and B2B activities developed on our site.

If you cannot agree with the terms of this Privacy Policy, please do not use WinTimePro services.

Personal data: general principles

Compliance with the law

WinTimePro is committed to protecting your personal data and makes every effort to comply with the most stringent provisions applicable in the European Union and in Belgium.

Person in charge of the treatment

WinTimePro is the controller of personal data under the European Directive EC 95/46. The Commission for the Protection of Privacy Policy is the supervisory body in Belgium and is located at Rue Haute 139 - 1000 Brussels.

Prohibition of the sale of data

WinTimePro will not sell personal information collected under any circumstances.

Use of personal data

We process your personal data to manage your account and to provide you with the services you expect from us.

We also use non-personal data for statistical purposes.

Right to correct or delete your personal data

You may contact us at any time with any questions regarding the protection of your personal data. You may also ask us at any time to review the personal data you have provided to us and request that we correct or delete it within a reasonable period of time, free of charge.

Consent

When you submit your personal data to us, the site's technological interface is configured to allow you to review and agree to the terms of the Privacy Policy.

Security

We make every effort to protect your personal data. In any case, you should know that the transmission of data via the Internet is inherently insecure. Therefore, we cannot guarantee the security of data transmitted over the internet.

Personal data: additional description

Collected information

We have the right to collect, store and process the following personal data:

- * information about your computer and your visits to the WinTimePro site, such as your IP address, geographic location, browser type, length of visit and number of pages opened
- * information relating to any transaction conducted between you and us through the WinTimePro Site.
- * information you provide to us for the purpose of registering with WinTimePro
- * information you provide for the purpose of subscribing to services offered by WinTimePro sites such as e-mail notifications and other newsletters.
- * any other information you choose to provide, including credit card information and other personal information necessary to complete your subscription payment. This is of course except for the free version where you will not be asked for any credit card information

Cookies

We use cookies on WinTimePro sites.

A cookie is a file sent by a server to a browser. The file is then sent back to the original server each time the browser displays a page from the server.

This allows the server to identify and track the browser's internet activity. We can send this type of file to your browser which will store it on your hard drive.

We use the information obtained to administer our website and to improve its navigability.

In a commercial context, we may also use this information to track your visits to our site so that we can customize the site based on your profile (language choices, general preferences, usual payment method, etc.).

It should be noted, however, that most browsers allow you to decline cookies.

Such a refusal will have a negative impact on the navigability of many sites, including WinTimePro sites.

Use of your personal data

Personal data provided to WinTimePro may be used for the specific purposes outlined in this Privacy Policy.

We reserve the right to use your personal data:

- * to administer the WinTimePro website
- * to improve your navigation on our site, if necessary by personalizing them
- * to improve access to the services available on our site
- st to allow you to access your account and your subscription on our site and to send you the corresponding invoices
- * to collect your subscription payments (except for the free version)
- * to send you commercial communications (non-marketing)
- * to send you e-mail notifications that you have specifically requested
- * to send you our newsletter and other marketing communications relating to WinTimePro that we believe may be of interest to you by email or similar technology
- * to provide third parties with statistical information about our visitors (note that this information does not identify you individually)

* to follow up on all requests and disputes or requests for assistance that you may send us

Other use

Beyond the uses reasonably necessary for the purposes identified in this Privacy Policy, we may also disclose information about you;

- * to the extent required by law
- * in connection with or on the occasion of certain legal proceedings
- * to defend and exercise our rights, including disclosure of personal data to third parties for fraud prevention and credit risk reduction purposes

Securing your personal data

Encryption technology

Since there are always risks associated with the communication of personal data whether in person, by telephone, or via the Internet, and since no technological security system is immune to hacking, WinTimePro undertakes to take all appropriate action to prevent and minimize the risks of unauthorized access, misuse, or any error relating to personal data.

We use encryption technology (SSL connection) to collect and transfer sensitive data.

Physical and logical protection of personal data

WinTimePro takes appropriate technical and organizational measures to protect Personal Data from accidental or unlawful destruction or loss, improper use, unauthorized access and disclosure, or alteration or destruction. WinTimePro requires its own service providers and other third parties who assist in providing WinTimePro's services to make a similar commitment to protect the personal data concerned.

Minors

Minors are not allowed to create a WinTimePro account.

External Hyperlinks

To simplify navigation for visitors, WinTimePro may include hyperlinks to third-party sites.

If you make use of these hyperlinks, it is necessary for you to review the Privacy Policy before giving your consent.

You acknowledge, however, that WinTimePro has no control over the content of its sites and therefore cannot assume any responsibility for their content or the processing of personal data on them.

Changes to the privacy policy

WinTimePro reserves the right to change this document at any time.
